Hi. This is Liz Cline with the Texas Department of Housing and Community Affairs. The purpose of this call is to conduct a public hearing with respect to the proposed Gateway at Trinity Forest multi-family development.

To give you an idea as to how we're going to proceed, there's a brief speech that I have to read for purposes of meeting the requirements of the Federal Code with respect to the public hearing. And at the conclusion of the speech, I will unmute the line. And if there's anybody that would like to make public comment, that will be your opportunity to do so. So I'll now begin with a brief speech.

Good morning. My name is Liz Cline. I would like to proceed with the public hearing. Let the record show that it is 10:03 am Tuesday, September 23, 2025, and we are conducting a public hearing on behalf of the Texas Department of Housing and Community Affairs with respect to an issue of tax-exempt multi-family revenue bonds for a residential rental community.

This hearing is required by the Internal Revenue Code. The sole purpose of this hearing is to provide a reasonable opportunity for interested individuals to express their views regarding the development and the

proposed bond issue. No decisions regarding the development will be made at this hearing.

The Department's board is scheduled to meet to consider the transaction on November 6, 2025. In addition to providing your comments at this hearing, the public is also invited to provide public comment directly to the Board at any of their meetings.

For the Gateway at Trinity Forest, the bonds will be issued as tax-exempt multi-family revenue bonds in the aggregate principal amount, not to exceed \$50 million in taxable bonds, if necessary, in an amount to be determined and issued in one or more series by the Texas Department of Housing and Community Affairs, the issuer.

The proceeds of the bonds will be loaned to LDG, the Gateway at Trinity Forest, LP, or a related person or affiliate entity thereof, to finance a portion of the cost of acquiring, constructing and equipping a multi-family rental housing community described as follows: A 330-unit, multi-family residential rental development to be located on approximately 30 acres of land located at or near 2050 Dowdy Ferry Road, Dallas, Dallas County, Texas, 75217. The proposed multi-family rental housing community will be initially owned and operated by the borrower, or a related person or affiliate thereof.
